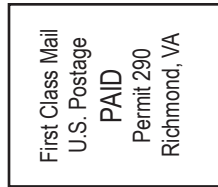

Overall Objectives

The overall objectives of this meeting will be to provide examples of challenges that members will encounter in the coming decade.

- To understand what has worked and what has not worked from the previous decade.
- To understand various viewpoints of education from the APA staff, to the residents currently in training and early career psychiatrists and how the education paradigm will shift over the coming decade.
- To provide examples of how telemedicine works and can be used to enhance patient care and access to mental health experts.

Target Audience
